## **New Business**

- Financial Reports Treasurer Smith explained the financials, the migration to online QuickBooks, onboarding MHP for the bookkeeping and annual 990, and took questions. A motion was made and seconded to accept the year-to-date financial reports, including the profit and loss and budget sheet. The 2024/2025 budget drafting process and Executive Director annual process were explained to the Board.
- Advocacy Update consisted of the following topics as presented by the Executive Director in a written report:
  - Post-session download
  - Interim legislative work for the coming year
  - WACCT programming to support trustees, ACCT Connect, hosting the Joint Education Interim Committee, and planning the WACCT Advocacy Spring Planning meeting on June 5<sup>th</sup> in Riverton. Finally, the Board decided to submit a presentation to the ACCT Congress (highlighting the Wyoming Innovation

Partnership) in Seattle in October and encouraged individual college boards to do the same.

- The WACCT Performance Committee was formed to perform the annual review of the Executive Director and the first-ever WACCT Board self-review. Members include Trustees Bob Salazar (LCCC), Reggie Clark (WWCC), and Dr. Brad Tyndall, (President, CWC)
- Asking each college to appoint one person to serve on the Shaping Wyoming's Future Student Awards Review Committee. President Erickson will follow up with each college to make sure everyone is represented.

- WACCT tuition policy recommendation The Board decided to be more involved with the WCCC tuition workshop and decision-making process.
- Letter supporting Governor Gordon's veto of HB 125 Repeal Gun Free Zones. It was decided to simply send the press release under the general name of the Association rather than listing the names of the trustees.
